## **CONFERENCE OF CHIEF JUSTICES**

## **Resolution 2**

## In Support of the Provision of Legal Services following a Major Disaster or Public Emergency

- WHEREAS, according to the Federal Emergency Management Agency (FEMA), at least one natural disaster occurs every week in the United States;<sup>1</sup> and
- WHEREAS, according to the Legal Services Corporation, low-income families and individuals are most vulnerable when disaster strikes, particularly in the areas of family and housing assistance, identification and documentation recovery, and emergency benefits;<sup>2</sup> and
- WHEREAS, the American Bar Association (ABA) has stated that "bar associations . . . have a duty to assist the general public in recovering from a disaster" with the goal of "enhanc[ing] community resilience should a disaster strike"; and
- WHEREAS, the ABA has urged state and local bar associations to create permanent standing committees dedicated to emergency management planning and response;<sup>4</sup> and
- WHEREAS, the ABA has devised a Model Rule on the Provision of Legal Services following Determination of Major Disaster, that would permit out-of-state lawyers to provide probono legal services in a jurisdiction affected by such a crisis, and 16 states have adopted that Rule;<sup>5</sup> and
- WHEREAS, various states have created a number of resources, such as disaster manuals and emergency-specific guides, to assist organizations that seek to provide legal services after a natural disaster strikes;<sup>6</sup> and
- WHEREAS, in the aftermath of Superstorm Sandy in New York, local bar associations and legal aid organizations collaborated to provide disaster-related legal services to victims, and with assistance from the New York State Bar Association, LawHelpNY published a toolkit intending to provide guidance to organizations in publicizing legal aid and disaster-related resources through social media and online search engines;<sup>7</sup> and
- WHEREAS, the State Bar of Texas has collaborated with Lone Star Legal Aid to develop a disaster manual structured in a simple question and answer format, which volunteer attorneys can easily use to field questions from individuals affected by disasters, concerning subjects such as FEMA assistance, landlord/tenant issues, real and personal property law, employment law, social security and finance, consumer protection, health

care, bankruptcy, replacement of lost documents, and family law, and linking attorneys to national and local resources to provide to clients;<sup>8</sup> and

WHEREAS, in response to flooding in Illinois in 2011 and 2013, the Illinois Bar Association created a disaster legal services manual targeted at residents and volunteer attorneys to address similar legal questions to those raised in the Texas manual, and further provided a disaster preparedness checklist listing important documents that evacuating residents should collect before leaving their homes;<sup>9</sup> and

WHEREAS, following the impact of Hurricane Florence on North Carolina and South Carolina, the Self-Represented Litigation Network partnered with local organizations and bar associations to use maps displaying demographic information to assess populations with unmet legal needs, and to coordinate a response assisting low-income individuals with civil legal aid;<sup>10</sup>

NOW, THEREFORE, BE IT RESOLVED that state courts encourage the bar associations in each state to establish emergency preparedness committees so that they are prepared to assist individuals of limited means in the event of a natural disaster or other public emergency in their state and in other states and territories.
